1. The unaudited financial results of the Company have been prepared in accordance with the Indian Accounting standards (IND AS) as prescribed under section 133 of the Companies Act 2013 read with the Companies (Indian Accounting Standard) Rules 2015 (as amended).
2. The above results for the quarter ended 30th June 2018, were reviewed by Audit Committee and approved by the Board of Directors in their meeting held on 14th August 2018 and Statutory Auditors have carried out limited review.
3. The Company's business activity fall within a single business segment i.e. Magnesium in terms of IND AS 108 on operating.
4. Consequent to the introduction of Goods and Service Tax (GST) with effect from 1st July 2017, revenues are required to be shown net of GST. The revenues for the earlier period i.e. before 1st July 2017 are shown including excise duty.
5. In view of very limited strength of employees, presently working with the Company, the requirements of IND AS-19 Employee Benefits in respect of gratuity could not be complied with. However provision for gratuity as required under Payment of Gratuity Act has been provided for and is being paid as and when the liability arises.
6. The figures of the quarter ended March, 2018 are the balancing figures between audited figures in respect of full financial years upto 31st March, 2018 and the un audited published year to date figures upto 31st December, 2017 being the date of the end of the third quarter of respective year, which are subject to limited review.
7. Previous figures have been regrouped or rearranged wherever necessary to confirm current year classification.



Limited Review Report – Financial Results

To the Board of Directors of Southern Magnesium and Chemicals Limited,

1. We have reviewed the accompanying Statement of Unaudited Financial Results of SOUTHERN MAGNESIUM AND CHEMICALS LIMITED ("the Company") for the quarter ended 30th June, 2018 (the "statement") being submitted by the company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Circular No. CIR/CFD/FAC/62/2016 dated July 5, 2016.

This statement is the responsibility of the Company's Management and has been approved by the Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34 "Interim Financial Reporting", prescribed under Section 133 of the Companies Act 2013 read with relevant rules issued thereunder and other accounting principles generally accepted in India. Our responsibility is to issue a report on these financial statement based on our review.

2. We conducted our review in accordance with the Standard on Review Engagement (SRE) 2410, Review of Interim Financial Information performed by the Independent Auditor of the Entity, issued by Institute of Chartered Accountants of India.
